## HITS APP SWEEPSTAKES - Iowa Wine & Cider Festival

"HITS App Sweepstakes: Iowa Wine & Cider Festival" is an online contest running from Monday, August 11<sup>th</sup> at 12:00 am through Sunday, August 20<sup>th</sup> at 11:59 pm, where three listeners will win a pair of tickets to the Iowa Wine and Cider Festival at Jasper Winery in Des Moines on Saturday, August 23<sup>rd</sup> from 1:00 pm to 4:00 pm.

To enter, listeners must download the free HITS 99.9 mobile app on their device and enter to win through the contest page before the contest closes on Sunday, August 17<sup>th</sup> at 11:59 pm. The contest officially opens on Monday, August 11<sup>th</sup> at 12:00 am and participants can submit their entry via a link on the HITS 99.9 App, directing listeners to a contest page where they must complete the entry form. Three winners will be randomly selected from the collected entries and contacted the following week of the contest.

Contestants may only enter once. Attempts enter multiple times, including by using someone else's personal information, will disqualify a listener. Only one win is permitted per household. The use of hardware or software that automates multiple entries into any Des Moines Media Group contest is prohibited and will disqualify its user. If there is a dispute over an entry, the authorized user of the email address given when entering will be considered the "entrant." This person must be eligible to win under these official rules. KIOA-HD2, HITS 99.9 has the final say as to who wins their contests.
